REGISTRATION FEE: (paid annually – non-refundable) \$ 50.00

MONTHLY RATES:

FULL TIME (4 or 5 full days per week)

K-3 & K-4: Effective until 9/1/08	\$ 570.00

School Age (summer only)	\$ 605.00
Second child discount	\$ 50.00
Each additional child discount	\$ 75.00

PART TIME: (3 full days or 5 one-half days per week)

K3 & K4: Effective until 9/1/08	\$ 425.00

School age (before/after care)	\$ 322.00

Daily rate per child (preschool) \$ 33.00

Daily rate per child (school age) \$ 35.00

The discount is granted to families who pay in full for the current month by the 10th of the month. If the entire fee for the current month is not paid by the 10th, the discount is not granted. Discounts are not given to before/after school age students.

The daily rate applies when a child starts attending after the first day of the month. If the total of the daily rate exceeds our monthly rate, the monthly rate will be charged as the total for the month. Before and/or after school care is available as space allows and only for school age students attending elementary school at Anchorage Christian Schools. The rate does not include in-service or school vacation days. In-service and school vacation days are charged our daily rate. PLEASE NOTE: Full days include up to 10 hours of care per day. Our 1/2 day program is mornings only, 5 hours or less, and children must be picked up no later than 1:00 P.M. Lunch is provided. Full time children have priority over part time children, therefore if all classes become filled, part time children are subject to relinquishing their slot to allow room for full time children. Should this occur, part time children will have the option of going full time instead of relinquishing their slot.

Our advertised rates are prepay rates, and payment for the entire month is due on the first day of each month in advance. Accounts not paid by the 10th of the current month will be charged a late fee of 2 %. Payment may be made by cash, check, credit card or online at www.acsedu.org. Automatic credit card payments may be set up in the finance office. Children may be withheld from class or asked to withdraw without advance notice to parents when payments become one month in arrears. We are unable to accept post

dated checks, and a \$25.00 fee will be charged on all NSF checks. Fees are not pro-rated for children who are absent for any reason. If your child is absent for any reason other than withdrawal, the entire fee will be required to hold your child's place.

A TWO-WEEK NOTICE IS REQUIRED PRIOR TO WITHDRAWAL. IF THE TWO-WEEK NOTICE IS NOT GIVEN, YOU WILL BE RESPONSIBLE FOR PAYMENT FOR THE TWO WEEKS FOLLOWING THE LAST DAY OF ATTENDANCE.

WE CLOSE AT 6:00 P.M. A LATE FEE OF \$1.00 PER MINUTE PER CHILD WILL BE CHARGED AFTER CLOSING TIME. THIS IS DUE AND PAYABLE TO THE CHILD CARE WORKER AT THE TIME THE CHILD IS PICKED UP.
