## Introductory Letter to Prospective Parents

Dear Parents:

Thank you for your interest in Anchorage Christian Schools. We have adopted an admissions policy that opens ACS to families who are like-minded spiritually, who are supportive of our philosophy, objectives, and standards of education, and whose children meet our enrollment standards. Our purpose is to serve families who desire not simply a private education but a distinctively Christian education for their children.

Before applying for admission to ACS please read the Student Handbook available online at [www.acsedu.org/publications/](http://www.acsedu.org/publications/). The Student Handbook will introduce you to many of our policies, procedures, and expectations for both parents and students.

The Handbook explains our religious purpose, mission, and beliefs. ACS unashamedly believes, teaches, and practices a literal interpretation of the Bible. If you do not agree with our religious mission and beliefs, enrolling your child in ACS will likely cause him or her confusion. For example, if a question regarding biblical lifestyles arises in chapel or your child's classroom, the speaker or teacher will answer from a biblical viewpoint consistent with our mission and belief statement. If your beliefs and lifestyle choices are not in agreement with our doctrinal stance, that answer will likely create conflict in your child's heart and mind. This internal conflict could drive a wedge between you and your child, cause your child to negatively judge you as a parent, or force your child to choose between our teaching and what he or she learns at home.

We respect your desire to place your child in the best possible learning environment, but if you are not in full agreement with our doctrinal positions, the Admissions Committee believes it will be best for all concerned if you do not enroll your child at ACS.

Biblical principles are integrated into every subject taught at our school. We consider all of our staff ministerial as they are committed not only to academic excellence, but also to teaching students how to apply the truths of God's Word to every aspect of life and modeling those principles in their personal lives. If you are in agreement with the teachings of God's Word, ACS will complement the beliefs and ideals your child is taught at home. We look forward to partnering with you to educate your child in God's truth.

## STATEMENT OF UNDERSTANDING AND COOPERATION

I understand:

- And accept that the education of children and youth is the primary responsibility of parents (Deuteronomy 6:4-9; Psalm 78:1-7). By asking Anchorage Christian Schools (ACS) to partner with this God-given task, I am committing in turn to support the school, its programs, personnel, and policies. It is my desire to have my child(ren) enrolled in ACS.
- That the standards of ACS do not tolerate profanity, obscenity in word or action, dishonor to God or the Word of God, disrespect to ACS personnel, or continued disobedience to the established policies of ACS.
- The educational services of ACS are engaged by mutual consent, and that either ACS or I reserve the right to terminate any or all services at any time.
- If my child(ren) is/are accepted I will cooperate with the school in having my child(ren) educated in accordance with Christian philosophy as set forth in the registration materials and Student Handbook. I further understand that agreement to these policies does not contractually bind ACS and these policies are subject to change without notice by the administration.
- Admission to ACS is a privilege, not a right, and admission for one school year, or any part of one school year, does not guarantee automatic admission for future school years.
- The Mission Statement of ACS, as a religious institution providing an education in a distinctly Christian environment, is to work hand-in-hand with Christian parents in educating their child(ren) according to biblical principles. ACS reserves the right to refuse or terminate enrollment based on unbiblical lifestyle choices of the student or parent. On those occasions in which the atmosphere or conduct within a particular home is counter to or in direct opposition to the biblical lifestyle ACS teaches, ACS reserves the right, within its sole discretion, to refuse admission to an applicant or to discontinue enrollment of a student. This includes, but is not necessarily limited to, living in, condoning, or supporting: sexual immorality; homosexual acts or same sex orientation; profession to be transgender or transgender actions; promoting such practices; or otherwise the inability to support the moral principles of ACS (Genesis 1:26, 27; Leviticus 20:13a; Matthew 19:4-6; Romans 1:26, 27; I Corinthians 6:9-11).
- ACS is a part of the educational ministry of the Anchorage Baptist Temple (ABT) which contributes significantly to ACS by providing our excellent facilities, resulting in a lower tuition rate for students. Since a negative spirit expressed through criticism of any ABT or ACS staff, privately or publicly, including social media sites, will undermine our ability to help your child(ren), ACS reserves the right to refuse or terminate enrollment for such criticism.
- School-related conflicts should be resolved using principles outlined in Matthew 5:23, 24; 18:15-20; I Corinthians 6:1-8. Slander and gossip, public or private, including on social media sites, is not in harmony with biblical injunctions to abstain from such behavior and seek peace (Colossians 3:8; Ephesians 4:29; I Peter 3:11).
- School trips are an important enhancement to the educational experience of students. I therefore give permission for my child(ren) to participate in all school activities including bus trips, sports, and school-sponsored trips away from the school premises.
- Discipline is essential for the welfare of each student, as well as the entire school. I give permission for, and pledge my cooperation with, my child(ren)'s teacher(s) and / or agent(s) of the school to make and enforce classroom regulations in a manner consistent with Christian principles and discipline as set forth in the Scriptures.
- And give my consent for the editing and use of one or more soundtracks, images, or recordings of my child(ren) for promotional purposes and release ACS and its employees and assignees from any and all claims resulting from such use and editing.
- Children have a right to privacy and I will respect that right by not posting online other children's images without first acquiring permission to do so from their parents.
- ACS does not discriminate on the basis of race, color, national, or ethnic origin in admissions or in the administration of any of its policies or programs.

### AGREEMENT

- I hereby affirm that I have read the Student Handbook and discussed its policies with my student. I certify that I consent to and will submit to all governing policies of ACS, including all applicable policies in the Student Handbook.
- I agree that I will insist that my child submit to its program, academic and disciplinary regulations, and all other requirements instituted by the administration and carried out by the principal and faculty.
- I agree to pay all tuition and fees associated with enrollment at ACS on time as outlined in the financial policies; if unforeseen events hinder this commitment I will communicate promptly and honestly with the Finance Office and Smart Tuition.
- I agree to hold the school and its agents harmless to the maximum extent allowable by law for any liability to my child(ren) or any guardian or parent thereof because of any claims on behalf of my child(ren) against the school or any agent thereof because of any injury to my child(ren).
- I agree to pay attorney fees, court fees, damages, or other costs that ACS or its agent should incur to defend itself against such action should legal action for any reason be taken against ACS or any employee or agent thereof on my child's behalf and the school or its agent not be found at fault.
